Invitation to Bid for the CONSTRUCTION OF MULTI-PURPOSE PAVEMENT

The City Government of Canlaon City, through Ordinance. Nos. 27 & 56, all series of 2018 intends to apply the sum of Nine Hundred Seventy Three Thousand Four Hundred Twenty & 22/100 (P973,420.22), being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Multi-purpose Pavement, Uptown Area, Brgy. Mabigo, Canlaon City.

The City Government of Canlaon City now invites bids for the Construction of Multi-purpose Pavement, Uptown Area, Brgy. Mabigo, Canlaon City. Completion of the Works is required 150 Calendar Days upon receipt of the Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the *Bids and Awards Committee Office, Canlaon City* and inspect the Bidding Documents at the address given below from 8:00 am to 5:pm, Monday to Friday.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The City Government of Canlaon City will hold a Pre-Bid Conference on **February 21, 2019- 1:30 PM** at the Office of the Bids and Awards Committee, Canlaon City, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before **March 7, 2019 – 1:30 PM, Office of the Bids and Awards Committee, Canlaon City**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB:
