## INVITATION TO BID FOR the <u>SUPPLY AND DELIVERY OF VARIOUS CONSTRUCTION MATERIALS FOR USE IN</u> THE IMPROVEMENT OF TB DOTS BUILDING

The Local Government of Canlaon City, through (NTP)SAA FUND 14-03-185<sup>1</sup> intends to apply the sum of Ninety One Thousand Eight Hundred Sixteen (Php91,816.00) being the Approved Budget for the Contract (ABC) to payments under the contract for supply and delivery of various construction materials for use in the Improvement of TB DOTS Building. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government of Canlaon now invites bids for supply and delivery of various construction materials for use in the Improvement of TB DOTS Building, (CHO) Brgy. Panubigan, Canlaon City. Delivery of the Goods is required 7 calendar days after issuance and receipt of Notice to Proceed. Bidders should have completed, within two years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from the City Government of Canlaon and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm, Monday to Friday.

A complete set of Bidding Documents may be purchased by interested Bidders on the day the Invitation to Bid is published up to the day of the Opening of Bids from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of:
